Annual dues are \$1,500, plus one time stock purchase fee of \$1,000 (payable over 3 years).

\_\_\_\_\_ *Individual Associate* – Full privileges for Island use; full access to all Club events; eligibility for membership on the Board of Governors. Annual dues are \$1,500.

\_\_\_\_\_ *Individual Corporate Sponsorship* – Available to Truman and Jefferson Corporate Club Sponsors only. All rights and privileges of Individual Associate Membership. The \$1,500 annual dues are waived. May initiate equity share of stock ownership and Individual Voting Membership through an additional payment of the \$1,000 one time stock purchase fee.

Club corporate sponsorship affords distinctive participation and recognition at all special events by the Club on the Island and in Washington, D.C., including all Capitol Hill receptions. Three annual corporate sponsorship options are available: Social @ \$3,000; Truman @ \$5,000; and Jefferson @ \$7,500. Corporate sponsorship options information available on the reverse side.

\_\_\_\_\_ *Junior* – All rights and privileges of Individual Associate Membership for those under the age 35. Individual voting membership also available with stock purchase, fee payable in full by age 35. Annual dues are \$750.

\_\_\_\_\_ *Non-Resident* – Available for individuals who reside more than 250 miles from the Club. Full access to the Club and all its facilities and programs. Annual dues are \$250.
