_____ **Junior** – All rights and privileges of Individual/ Voting or Individual/Associate Membership for those under age 35. Annual dues are \$750. For Junior Individual/ Voting, select:

 _____ or payable pro-rata (with payment in full by age 35).

_____ **Non-Resident (Voting or Associate)** – Available for Individuals who reside more than 250 miles from the Club. Full access to the Club and all its facilities and programs. Annual dues are \$250.

No dues or special privileges are associated with this Honorary status designation. I understand that remaining a member in good standing requires continuing payments of annual dues and that, if holding a share of stock, that such stock is assessable for dues and other payment due to the Club. I also understand that the sale of such stock has not been registered under either federal or state securities laws and cannot be sold, transferred, pledged, hypothecated or assigned unless so registered, or if an exemption from registration is available. I also understand that, if owning a share of stock, that such stock is only transferable in accordance with the By-laws of the Club.
